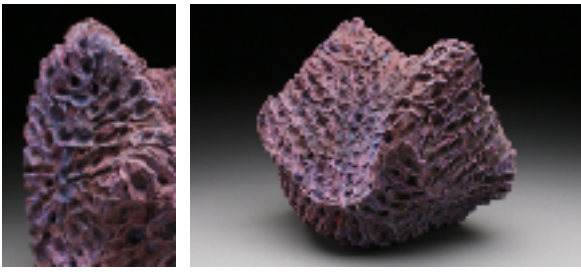

Terms and Conditions

1. Photographer's Standard Price List. The charges in this Agreement are based on the Photographer's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect for that present time.

2. Assignment. Neither this Agreement nor any rights or obligations hereunder shall be assigned by either of the parties, except that the Photographer shall have the right to assign monies due hereunder. Both Client and any party on whose behalf Client has entered into this Agreement shall be bound by this Agreement and shall be jointly and severally liable for full performance hereunder, including but not limited to payments of monies due to the Photographer.

3. Payment. Client shall pay the Photographer within thirty days of the date of Photographer's billing, which shall be dated as of the date of delivery of the Assignment. The Client shall be responsible for and pay any sales tax due. Time is of the essence with respect to payment. Overdue payments shall be subject to interest charges of 30% percent monthly.

4. Deposit and Payment. The Client shall make a deposit to retain the Photographer to perform the services specified herein. At such time as this order is completed, the deposit shall be applied to reduce the total cost and Client shall pay the balance due. If the Client refuses delivery of the order or refuses to pay within thirty (30) days of this order, Client shall be in default hereunder and shall pay 30% percent interest on the unpaid balance until payment is made in full.

5. Cancellation. If the Client shall cancel this Agreement 5 or more calendar days before the session date, any deposit paid to the Photographer shall be refunded in full. If Client shall cancel within 5 days of the session date and if the Photographer does not obtain another assignment for that time, liquidated damages shall be charged in a reasonable amount not to exceed the deposit.

6. Copyright and Reproductions and Client Usage. The Photographer shall own the copyright in the image(s) created however the client may use images for his or her portfolio, website, internet submission, samples, self-promotions, entry in photographic contests or art exhibitions, editorial use, or for viewing within or on the outside of the Photographer's studio. The Client is obtaining copies for personal use only, and shall not sell said copies of images or reproductions or duplicates made from original slides, negatives, prints, digital or electronic media. Duplication of images are allowed by the Client. If the Photographer desires to make use of the above stated or other uses of images within this contract, the Photographer shall do so without obtaining the oral or written permission of the Client.

7. Additional Usage. If Client wishes to make any additional uses for monetary gain, Client shall seek permission from the Photographer and pay an additional fee to be agreed upon or negotiate a buy out agreement.

8. Acknowledgement: All parties hereunder and in agreement within this contract/invoice acknowledge by signature, the understanding of all terms and conditions, and have inspected art / slides / digital images and all media pertaining to said invoice. Client as well as client affiliations upon delivery and pick-up and have concluded that the art, is in original and sound condition(s), as well as all facilities/site specific locations are of clean and orderly conditions and approved of by client.

9. Miscellany. The terms and conditions of this Agreement shall be binding upon the parties, their heirs, successors, assigns, and personal representatives; this Agreement constitutes the entire understanding between the parties; its terms can be modified only by an instrument in writing signed by both parties, except that the Client may authorize additional fees and expenses orally; a waiver of a breach of any of its provisions shall not be construed as a continuing waiver of other breaches of the same or other provisions hereof; and the relationship between the Client and Photographer shall be governed by the laws of the State of GA.
